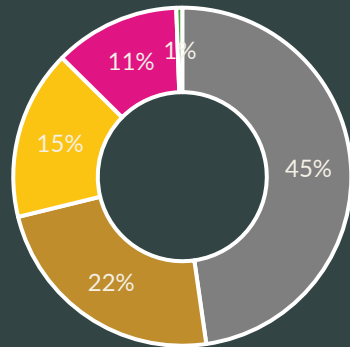

Emissions

- We calculated our emissions footprint via Carbon Positive Australia. As a small operation, our greenhouse gas emissions total was small, but we chose to offset this via our partnership with Carbon Positive Australia.
- In addition to offsetting, we plan to reduce our footprint in FY23, with reduced car usage and a transition to Diamond Energy.



Waste

- Our waste streams are minimal, though we aim to lead by example and ensure that all waste is properly disposed of.
- We keep separate recycling containers for each of the below "waste" categories, so that they can be sent to the appropriate re-use or recycling channel, with nothing going to landfill:
 - E-waste
 - Organics
 - Hard plastics
 - Soft plastics
 - Paper
 - Metals
 - Stationery
- We are members of the Australian Circular Economy Hub and follow circular economy principles through our actions, as well as supporting our clients to do the same.
